**NOTICE OF PROPOSED PROPERTY TAX INCREASE  
FOR LINDOP SCHOOL DISTRICT NUMBER 92,

- I. A public hearing to approve a proposed property tax levy increase for Lindop School District Number 92, Cook County, Illinois for 2018 will be held on November 20, 2018 at 7:00 p.m. at the school cafeteria at the School District, 2400 South 18<sup>th</sup> Avenue, Broadview, Illinois.

- II. The corporate and special purpose property taxes extended or abated for 2017 were \$5,949,891.

The proposed corporate and special purpose property taxes to be levied for 2018 are \$6,246,000. This represents a 4.98% increase over the previous year.

- III. The property taxes extended for debt service and public building commission leases for 2017 were \$443,579.

The estimated property taxes to be levied for debt service and public building commission leases for 2018 are \$443,579. This represents a 0.0% increase over the previous year.

- IV. The total property taxes extended or abated for 2017 were \$6,393,470.

The estimated total property taxes to be levied for 2018 are \$6,689,579. This represents a 4.63% increase over the previous year.

## TAX RESOLUTION

WHEREAS, Section 17 of Illinois School Code authorizes the Board of Education of Lindop Public School District No. 92 to levy, by proper resolution, special taxes for various purposes.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION, LINDOP PUBLIC SCHOOL DISTRICT NO. 92, COOK COUNTY, ILLINOIS, AS FOLLOWS:**

**Section 1.** The County Clerk of Cook County is hereby authorized and directed to extend the following special taxes on behalf of this school district the sum of \$4,363,000.00 as a special tax for Educational purposes, the sum of \$567,000.00 as a special tax for Operations and Maintenance purposes, the sum of \$102,000.00 as a special tax for Transportation purposes, the sum of \$45,000.00 as a special tax for Working Cash purposes, the sum of \$150,000.00 as a special tax for Illinois Municipal Retirement purposes, the sum of \$150,000.00 as a special tax for Social Security purposes, the sum of \$89,000.00 as a special tax for Fire Prevention and Safety purposes, the sum of \$423,000.00 as a special tax for Tort Immunity purposes and the sum of \$357,000.00 as a special tax for Special Education purposes. On the equalized assessed value of the taxable property in School District 92, Cook County, Illinois for the year of 2018.

**Section 2.** The Resolution shall be in full force and effect upon its adoption.

**RESOLUTION REGARDING THE ESTIMATED AMOUNTS  
NECESSARY TO BE LEVIED FOR THE YEAR 2018**

WHEREAS, the Truth in Taxation Law requires that all taxing districts determine the estimated amounts of taxes necessary to be levied for the year not less than twenty (20) days prior to the adoption of the aggregate tax levy of the district; and

WHEREAS, the Law requires that public notice be given and a public hearing be held on the district's intent to adopt an aggregate tax levy in an amount which is more than 105% of the amount extended or estimated to be extended upon the final aggregate levy extensions, plus any amount abated, exclusive of election costs, for the preceding year;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education for Lindop School District 92, Cook County, Illinois, as follows:

Section 1. The aggregate amount of taxes, estimated to be levied for the year 2018, is \$6,246,000 exclusive of levies for bond and interest and including estimated levies for specific purposes as follows:

Section 2. The amount of taxes estimated to be levied or to have already been levied for bond and interest purposes for the year 2018 is \$443,579.

Section 3. If required, the administration shall cause an appropriate public notice to be published and a public hearing to be scheduled on the levy, such hearing to be held on November 20, 2018, or such other appropriate date as determined by the Board President.

Section 4. This resolution shall be in full force and effect forthwith upon its adoption.
